Description of Organizational Activities:

Shoebox Ministry attempts to meet the needs of the homeless and working poor individuals in the Maricopa County area by:

- Distributing (free of charge) personal hygiene kits to homeless and working poor agencies for distribution to their clients.
- Providing Domestic Violence Agencies and Family Shelters with gift filled purses for moms on Mother's Day.
- Hosting drive for new undergarments during the month of October that are given to local homeless and working poor agencies.
- Supplying new socks during the Christmas Holiday to local homeless and working poor agencies.
